

The healthcare disparity between his hometown in Ethiopia and the U.S., where Nuredin Ousman works as a dialysis nurse, is stark. "There were only three general practitioners, one internist and one surgeon," Ousman said about his hometown hospital in Tepi, Ethiopia, home to roughly 25,000 people. "The other

five or six patients. There it might be one nurse to 20 or 25 patients."

Patients who need more involved care are commonly referred to a city about 83 miles away. The trip can take more than three hours by car. Ousman is determined to make a difference. When he learned about Rendevor's Equipment Retirement Program, Ousman rolled up his sleeves and began organizing.

thing is the ratio of patients to nurses is really, really very big. Here, it might be one nurse to

Rendevor's Equipment Retirement Program launched earlier this year. It replaces dialysis machines that have exceeded their useful life due to age or technological changes. As a result, Ousman has access to roughly 30 devices he plans to ship to Tepi. In addition to the equipment donation, Rendevor plans to help cover the shipping costs.

This isn't Ousman's first experience coordinating medical shipments to Ethiopia. He was inspired to begin organizing aid shipments after a February 2020 visit to his home. Returning to the U.S., he found others in the States who shared his passion. The group, Ethiopian Healthcare Association, began orchestrating shipments of medical equipment and supplies.

This is the third shipment Ousman has worked with the group to send to Ethiopia since 2023. The group, 65 healthcare workers that include doctors, respiratory therapists, physical therapists, and nurses, donated their own money and used grassroots fundraising to pay for

"We finance it ourselves. Each of us raised about \$200. And we went to a church on an Ethiopian holiday. We explained what we were doing. We got a little bit of support from the church, but most of the money is contributed by the group," Ousman said. "The good thing is everybody is willing to give because they know what it's like in our country."

"We are forming a nonprofit to get our own website. We want to make it official," Ousman He even began translating patient education materials that he and colleagues use here in the U.S. He sends the translated documents to healthcare workers in Ethiopia.

Ousman was awarded a visa and emigrated to the U.S. in 2013, the same year he began his

nursing education. Earning his associate's degree in 2016, he began working as a medical/surgical nurse before completing his bachelor's degree in nursing in 2021.

Ousman has been a dialysis nurse with Rendevor Dialysis since early 2023. "I have a family member who is on dialysis. So I always wanted to be a dialysis nurse when I was back home and when I was in nursing school," he said.

Combining his passions of caring for dialysis patients and supporting his hometown come naturally to him. As his efforts grow, his goal is to expand dialysis services available to people

"We're planning to have our own dialysis centers ... to give free treatments or just provide them at very, very little cost."


