Community **Hospital South**



Challenge

Soon after Community Health Network's third-party dialysis provider issued a 90-day notice to terminate their contract for four Indianapolis-area hospitals, the system's leaders engaged an alternative provider. Unfortunately, Community Hospital South's unique needs based on volumes and on-site capabilities placed the facility on an undetermined waiting list for services. In response, the hospital's leadership, including Director of Nursing Jamie Sowers, began exploring ways to establish their own insourced dialysis program.

- There was an urgent need to establish in-house hemodialysis capabilities to avoid patient transfers to competitor hospitals.
- » Newly purchased equipment and trained nurses alone proved insufficient to fully launch and sustain a comprehensive, self-sufficient program.
- » The hospital faced challenges in navigating complex biomedical policies and meeting regulatory requirements due to a lack of inhouse expertise.
